## PERMANENT ROAD ORDINANCE RELATING TO THE PARKING AUTHORIZATION OF LARGE VEHICLES

**A2022-006**

### **The Mayor of VICQ SUR MER**

Having regard to the General Code of Local Authorities, and in particular Articles L.2212-1 et seq.,  
Having regard to the General Code of Local Authorities, and in particular Articles L.2213-1, L.2213-2,  
L2213-4 et seq.,

Having regard to the Highway Code,

Having regard to the Criminal Code

Having regard to the Public Health Code,

Having regard to the ordinance A2022-007 of March 31, 2022 relating to the ban on parking large  
vehicles along the coast,

Considering that due to the growing increase in the number of large vehicles using the municipality  
and the resulting parking difficulties, particularly on the edge of or near beaches, it is essential, for  
reasons of public safety, health and tranquility, to regulate the parking of these vehicles in areas  
reserved for this purpose;

Considering that the parking of a large number of converted vehicles is taking place on a massive  
scale in various places in the municipality, causing nuisances affecting hygiene, cleanliness and  
tranquility, particularly at night;

Considering that it is appropriate, in our municipality with high tourist traffic, to reconcile the right to  
vehicle parking with public order;

Considering that the prolonged parking of large vehicles, whether or not providing accommodation,  
in car parks or on the roadway can be observed as an abusive use of the public highway and that it is  
therefore appropriate to regulate the parking or stopping of these vehicles on the verges, car parks  
or other outbuildings of public highways open to traffic.

Considering that the size of certain vehicles is such as to obstruct the roads and make access for  
emergency and maintenance vehicles very difficult, given the narrowness of certain public roads.

Considering that the provisions to be taken must subject parking of the same nature and duration to  
an identical regime, but that the principle of equality of citizens before the law does not prevent  
specific and motivated differentiations between the various categories of users and roads,

Whereas the parking of large vehicles is strictly prohibited on the seashore,

Considering that the presence of certain vehicles during the summer period is particularly dense and  
that it represents a hindrance to free movement and the visibility of natural spaces.

Considering the provision by the municipality of parking areas for oversized vehicles.

The parking of large vehicles used as housing in the commune of Vicq sur Mer should be regulated.

# ARRESTED

## **Article 1 – Parking Permit**

Parking of large vehicles is permitted under the conditions defined by the Highway Code, on all roads open to public traffic and in municipal parking lots, with the exception of the areas listed in Article 3. Parking means parking without unpacking, without installing an awning, or camping table, in order to avoid any unlawful occupation of public property.

Parking refers to the immobilized state of a vehicle on a public road, without the presence of its driver or occupants.

## **Article 2 – Vehicles concerned**

Large vehicles, and those covered by this decree, are defined as vehicles with a length greater than 5 meters, a width greater than 2 meters, and an overall width greater than 2 meters.

## **Article 3 – Spaces reserved for large vehicles**

Parking is permitted in the spaces designated below:

- Hameau de la Mer car park (hameau entrance)
- Town Hall green space (Gustave Lamache car park)
- Gouberville Church car park

To allow as many people as possible to use these spaces reserved for large vehicles, parking for the same vehicle is limited to 24 (twenty-four) consecutive hours.

## **Article 4 – Illegal Appropriation of Space**

Any appropriation, even temporary, of public land open to the public around large vehicles is prohibited, including with regard to the reservation of spaces and parking.

## **Article 5 – Respect for Public Safety, Peace, and Health**

Parking of large vehicles is permitted subject to compliance with the requirements set out in the laws and regulations in force, particularly with regard to:

Compliance with public health rules, including the prohibition of dumping, running off, and emptying wastewater on shoulders or in stormwater drainage manholes, as well as any deposit of litter,

Compliance with rules relating to public peace; in particular, it is prohibited to disturb the peace of the neighborhood by making any noise,

Compliance with the rules relating to the use of fires and barbecues.

## **Article 6 – Advance Signage and Signaling**

The regulatory advance signage and signaling required for the implementation of this decree will be implemented in the affected areas.

## **Article 7 – Display and Advertising**

This decree will be posted in town halls and on road signs.

**Article 8 – Appeal Procedures and Time Limits**

This decree may be subject to legal action before the CAEN Administrative Court within two months of its posting.

**Article 9 – Execution**

The Mayor and the Chief of the Gendarmerie Brigade are responsible, each within their respective jurisdiction, for the execution of this decree.
